



**AFFIDAVIT**

**DYED DIESEL FUEL FOR USE IN A VESSEL OPERATED IN INTERSTATE OR FOREIGN COMMERCE**

**CERTIFY THE FOLLOWING:**

1. The fuel purchased from SSI Petroleum (aka SSI Lubricants, LLC) are to be used only on board the named vessel and in connection with transporting persons or property in interstate or foreign commerce and are appropriate to carry out the purpose for which the vessel is designed, equipped, and used. **[Rule 12A-1.064(5) F.A.C.]**

2. The named vessel is used to transport persons or property for hire in interstate or foreign commerce in non-Florida waters, including the mileage from the territorial limit to port dockside and return into international waters. The fuel will not be used to operate the vessel in or on the canals or waterways, or within the territorial waters, of Florida and is not subject to Florida sales tax. **[Section 206.9941 and Sections 206.9935 (2) and (3)]**
